TRANSPORTATION: The Sheraton Times Square (811 7th Ave., New York, NY 10019) is accessible by Subway Lines B/D/E to 7th Ave station, Subway Line 1 to 50th St station, Subway lines N/Q/W/R to 57th St/7th Ave station and by Buses on 6th/7th/8th Avenues. Metro North trains connect with Shuttle Subway to 42nd St which connects to Subway 1. LIRR trains connect with Subways E/1. Due to weekend Subway service disruptions, please check web.mta.info. Members traveling from Hudson Valley and Upstate regions, please contact your representative for travel options.

Buses for NYSNA members will be available (if minimum attendance # is met) from Staten Island, part of Queens, Long Island and Hudson Valley. Amtrak and plane travel will be available for Upstate region.

HOTEL INFORMATION: If overnight stay is needed, you must reserve a room at the Sheraton Times Square (811 7th Ave., New York, NY 10019) by calling the reservations line at 888-627-7067 or 800-325-3535. Be sure to mention NY State Nurses or NYSNA to get the negotiated rates of \$359 single/double occupancy, \$389 triple rate and \$419 quad rate (rates do not include 14.75% tax and \$3.50 surcharge). Reservations are accommodated on a first come, first served basis. The NYSNA negotiated rates will be honored through November 5, 2018 provided there is availability.
